1. Missouri Tax Credits Take Up Increasing Portion of State Revenue

The reconvened Tax Credit Review Commission met this week in Jefferson City. The commission heard from the State Budget Director, Linda Luebbering about the impact of Tax Credit redemptions on Missouri's budget and ability to fund services. Some highlights of the information:

- Missouri Tax Credit redemptions reached historic highs in fiscal year 2012, costing \$629.3 million. The amount was a 15 percent increase over the previous year, but the amount is more than double what the state spent on tax credits in fiscal year 2000.
- As a portion of the general revenue budget, tax credits now comprise 8.6 percent of the total general revenue budget.
- In the last year, Missouri spent more on tax credits than it did on corrections or on the mental health budget.

2. State General Revenue Inching Up in FY 2013

Missouri general revenue collections for fiscal year 2013 grew by 2.8 percent in August. However, corporate income and individual income tax have had slight declines compared to the previous year. Missouri revenue remains well below the level achieved prior to the recession. <u>Read more here</u>

4. U.S. Census Release: Poverty Continues to Climb

The United States Census Bureau released the data on 2011 poverty levels from its Current Population Survey on Wednesday, September 12. The survey results show that **one in every seven Missourians was living in poverty in 2010-2011, 900,000 people during that two year period:**

- In 2010-2011, 15.2 percent of Missourians lived in poverty
- This represents a steep increase since 2006-2007 when 12.1 percent of Missourians lived in poverty
- Poverty grew from 9.4 percent in 2000-2001 to 15.2 percent in 2010-2011, an increase of more than 5 percentage points over the decade
- The median income in the state dropped from \$55,708 in 2000-2001 to \$46,518 in 2010-2011 (in 2011 dollars)
